### DAY 1 – THURSDAY 12<sup>TH</sup> JULY 2018

#### 1. 43<sup>RD</sup> CONSULTATION OPENING & CANDLE LIGHT SERVICE

The opening service liturgy and worship was led by *Rev Ralo*, after singing *Hymn 13 Tswana* – *Modimo oa Boikanyo*, the *Rev M. Seekoei* led the opening of the 43<sup>rd</sup> Annual BMC Convocation in prayer. Hymn 116 Xhosa – Lizalis'idinga laKho was sung. The Scripture Reading was taken from Acts 3:1-10 followed by Siyakudumisa.

The key message was premised on Acts 3. verse 6 of the text - "*In the name of Jesus Christ of Nazareth, get up and walk".* 

The Bishop of the Cape of Good Hope District, *Rev Michel Hansrod* delivered the sermon. On a personal note he expressed being honoured to be part of the 43<sup>rd</sup> Annual BMC Convocation and related that he was introduced to the BMC at the age of 18 and it is in this movement that he ate from the pot of Black Theology. As he grew up, He believed in the Theology of ranks in life i.e. Whites, Coloured, and Indians however in the BMC he was just a human being which was a defining moment for his leadership.

He spoke on how the BMC is a transformative agent, a movement that uplifts every person's living conditions and that it has formed many who have served in the leadership of the church.

#### Key Highlights of the Message

He preached on Acts 3:1-8, based on the theme of the Consultation – "Arise and walk, from dependency to agency". He related the message to the "Thuma Mina" – Republic of South Africa, State of Nation Address (SOPA) it's a promise of a new dawn but nothing seems to change much. Acts 3:1-8 –The story in acts is a new story yet the same old story – which nothing has changed.

The BMC Consultation 2018 theme is wonderful news that suggests to expect the same old things but life is altered when Jesus becomes part of our lives. A story of any other day in the life of Peter and John going to the temple for prayer service. They might have encountered the lame beggar before ...

This story reminds us that nothing regarding brokenness is designed by the original Creator. This was a different day for the beggar, it was his divine appointment. The beggar did as he always does, beg however this time he expectantly as he was commanded gave attention to Peter. This time was different – it was not silver and or gold but healing. With his right-hand Peter helped the beggar up and he walked into the temple with them.

**Bishop Hansrod** challenged the BMC that as people we are quick to give hand-outs to support people in their conditions than introducing the people to Jesus. We create dependency so that we are able to hold people in our power. In most cases our policies have exclusions more than inclusions if we take people out of dependency, we fear that we will not be important.

The Sermon was followed by a *Sacrament* of *Holy Communion Service* which was then followed by a *Candle Light Service*; the candle light service was conducted for the Gender Equality further marking Thursday 12<sup>th</sup> July 2018 Special BMC Programme focusing on Gender Equity and LGTBIQA.

#### 2. WELCOME TO CAPE OF GOOD HOPE DISTRICT

The Bishop of the Cape of Good Hope District welcomed the consultation and *Rev M Molo* home as he presides over the 43<sup>rd</sup> Annual BMC Convocation.

On behalf of the Cape of Good Hope District, the BMC Chairperson *Mr Bathembu Lugulwana*, welcomed the consultation to the Cape of storms and thanked us for having brought rain to Cape Town since they have been experiencing drought leading to serious water shortages.

#### 6. <u>CONFIRMATION OF MINUTES AND MATTERS ARISING</u>

The minutes of the 42<sup>nd</sup> Black Methodist Consultation that was convened on the 6<sup>th</sup> - 9<sup>th</sup> July 2017 at the Nelson Mandela Metropolitan University in Nelson Mandela Bay, Grahamstown District, under the theme: *"Love thy neighbour: reimagining a society of love and justice";...and who is my neighbour?"* were taken as read and confirmed as a true reflection of the previous consultation.

#### 7. NOTICES OF MOTION – RESOLUTIONS

#### 7.1. MODERN FAMILIES

**Preamble** - Noting the reality of the emerging of the modern families, in particular, the children of the LGBTIQ+. Also noting that the DEWCOM document is silent on the reception of children from such families through baptism. And recognising the need for the Church to be proactive in this issue to avoid any conflict.

#### Resolve

- Healthy conversations must start amongst us to influence the work of DEWCOM around same-sex relations.
- Non-judgmental approach and conducive dialogues, preparatory programs especially to the children ministry practitioners must be designed.

#### <u>Resolutions Committee Recommended:</u> <u>Acceptance with amendments and</u> <u>notes</u>:

- While conversation is taking place on same sex relations, that conversation should include the reception of children from same sex relations into the Church through baptism.
- We note that there is a Children's ministry practitioner training program already taking place through the Youth Unit/Children's Desk and these preparatory programs can be done there.

*Preamble* - We, note the new despicable, deplorable and dehumanizing culture that has captured some of our young girls whose livelihood is defined by

amassing materialistic possessions by giving their lives to older immoral men who ought to protect them.

- i. We openly bring this out by talking about it in all spheres of society.
- ii. As parents, we take keen interest in our daughters, sisters and nieces by actively engaging them on the unexplained and unsubstantiated flamboyant lifestyle.
- iii. We take full responsibility of speaking truth to power, to the powerful, sometimes political leaders in society to be accountable, responsible, honest and respectable citizens.
- iv. Hosting open dialogues with young women and men to address this dehumanizing culture.
- v. Opening up our Churches to be centres for rehabilitation of both the perpetrators and victims.
- vi. Call on the MCSA to expedite the implementation of one of the Mission Pillars on Human Empowerment and Economic Development to offer our young people alternative meaningful and dignified ways of living.

#### Resolutions Committee Recommend: Accepted with amendments and notes

- i. We note that blessers are not a phenomenon that only affects the girl-child, the boy-child can also be affected.
- ii. We also note that the language of victim and perpetrator used in line 5 may not be applicable to this issue as this issue may not be a crime in-and-of-itself except in cases where there is statutory rape.

#### 9. <u>GENDER EQUITY FOCUS</u>

- **9.1** The 12<sup>th</sup> July 2018 Thursday, Day 1 of the 43<sup>rd</sup> Annual July BMC Convocation was of critical and high importance marked by setting aside half of the business day to give special attention to issues of Gender Equality as a transformation imperative.
- **9.2** The General Secretary gave a road map and the desired outcomes for the intervention as a response to the resolution taken in 2017 July at Port Elizabeth, NMMU; thereafter introduced the Programme Director for the Gender Equality Focus, Ms Mpume Mhlongo of Natal Coastal.

#### 9.3. Contents Overview

- Dr. Nontando Hadebe, Key Note Speaker, (full paper attached as Annexure. A.) shared the following observations:
- **Gender is a social construction of sex** we are born either female or male but our culture, society and religion socialize us into what the ideals of being a woman or man the prescriptions, limitations, behaviours, social status, power and relationships.
- So, *everyone is gendered not only women*, men are gendered too and so are LGBTIQ.
- Since gender is a social construction, it can be changed and has been changing over time.
- **Dr. Hadebe** further focused on the following main points, women status of the women in the bible that translates to the way women are treated in churches and society.
  - a. Churches are divided on the status of women and LGBTIQ+ and yet they claim that all human beings are created in the image of God;
  - b. The second aspect was the concept of 'dangerous memories'/ 'poisonous memories' as tools of change, transformation and new visions; ... Biblical 'texts of terror' for Women;
  - c. *Culture as a 'hiding place'* for those who refuse to honour the rights given by constitution.

#### 10. MEMORIAL SERVICE – REV NOMPITHIZELO SIBIDLA

In remembering BMC fallen hero's and heroines, the *Rev NP. Sibidla* read Romans 14:8-9:

"If we live, we live for the Lord; and if we die, we die for the Lord. **So, whether we live or die, we belong to the Lord.** For this very reason, Christ died and returned to life so that he might be the Lord of both the dead and the living."

The **Rev NP. Sibidla** challenged the consultation that it is not enough to know the Gospel – it needs to impact every aspect of our lives for the Christian goal is that "whether we live or **die we belong to God**"

Our goal as Christians is *to deny ourselves for Christ and follow Him* and we must never *live for ourselves but for the one who called us*. We are not in the business of pleasing ourselves but one that pleases God.

A total of 6 members were remembered in 2018 during the 43rd Annual July BMC Convocation.

## DAY 2 – FRIDAY 13TH JULY 2018

The Morning Devotions were led by *Mr. Sizwe Mvusi*; making reflections on St. Luke 8:40-50: *"Jesus Raises a Dead Girl and Heals a Sick Woman"*:

• Jesus said to Jairus, "Don't be afraid; just believe, and she will be healed."

- Jairus, the synagogue leader demonstrated faith; *fell at Jesus' feet, pleading with him to come to his house because his only daughter, a girl of about twelve, was dying;*
- Jairus forgot about his status in society and at the synagogue he showed total dependency to Jesus hence the response, "Don't be afraid; just believe, and she will be healed."
- The text demonstrates faith that heals when dependency is on Jesus; "Arise and walk, from dependency to agency";
- Jesus delayed the agency for healing and transformation for Jairus daughter, she died but listen to Jesus response, "Don't be afraid; just believe, and she will be healed."
- Perhaps Funeral Services/Parlour were ready to receive the tender of a funeral for Jairus daughter but agency in Jesus arrived, *"Arise and walk, from dependency to agency"* ... funeral cancelled and or postponed.

#### 11. CHAIRPERSONS ADDRESS

**Rev M Molo** delivered his address to the 43<sup>rd</sup> BMC Convocation address at the Bellville Campus - analysing the theme "*Arise and walk, from dependency to agency*" and charging into action all present. "We who gather here are called by this noble and sacrificial history to spend all that we are in pursuit of the noble dreams of our forebears and the beautiful dreams of our people inspired by the Kingdom of God. We cannot be consumed by our vanity pursuits that is disconnected to that which is noble.

We meet under the Theme <u>Arise and Walk: From dependency to Agency</u> inspired by our history as a people that sought to move beyond victimhood to architects of the future, they wanted inspired by God's vision for his world."

- Black people are facing the challenge of moving from dependency to agency
- This dependency manifests itself in the culture where black people are forever complaining without taking any responsibility. This leads to further sense of powerlessness where we are forever waiting for a human saviour to sort out our problem
- *This culture finds serious expression in the political arena*. There is a paralysing notion of representative rather than a participatory democracy.
- In the *Church context, the BMC* is at the point at which it needs to demonstrate and model agency. We have the fundamental responsibility to live and act that which we believe in
  - We need to embody what Alice Walker called; We are the ones we have been waiting for

#### 12. EXECUTIVE ORGANISATIONAL REPORT

The General Secretary, *Xhanti T. Mhlubulwana* presented the BMC Executive Organisational Report for the period July 2017 until June 2018. The report argued for the

- 'Rapid Values Erosion;
- **Collapse of Familiar Systems** etc.' due to **rapid changes** in the world BMC exists in versus at its foundations.

BMC must lead the MCSA *to reform its leadership bottom-up*, the milestones and or fundamental shifts along the way must include reforms from: -

- Compliance to results,
- Inefficiency to effectiveness,
- Responsibility to accountability, and
- Inputs to outputs.

#### 13. FINANCIAL REPORT

## 20. DISCERNMENT JOURNEY – MCSA GEN. SEC 2018 SEPT. & PB-2019 MAY

• The Black Methodist Consultation (BMC) February Planning Meeting held in the Natal West District on 16-18 February 2018, among the items that the Connexional Executive presented was the MCSA Elections Calendar, thus to allow BMC to be proactive in approach.

- The office of the General Secretary of the Methodist Church of Southern Africa (MCSA) the current incumbent comes to an end at the year-end of 2019 by implications that meant the elections for that office would be conducted at the floor of 2018 MCSA Conference in September, Mozambique.
- The BMC only has the July Consultation to collectively apply its mind and take a position. To this end the Extended Connexional General Executive Committees at Natal West **appointed a BMC Discernment Task Team** 'to prepare, on the basis of input from the Districts, the report plus recommendation(s) to be presented for consideration at the July 2018 Consultation in Cape Town'
- The meeting accepted the above recommendation and elected the following names to serve in the Discernment Task Team, the committee was further given powers to coopt as and when needing additional capacity:

  - II. Rev Mbatu Bosman
  - III. Ms Mapholo Gwangwa

- The Extended Connexional General Executive Committees at Natal West further noted that per current retirement prescripts per Laws and Disciplines of the MCSA the office of the Presiding Bishop incumbent would be retiring in the year 2020, therefore by implication May 2019 Synods across the Connexion should elect new PB to start office in January 2021.
- The mandate of the above listed BMC Discernment Task Team 2018 was further extended to include the office of the Presiding Bishop for May 2019 elections, for finalisation of BMC recommendations and or position in July 2018 Cape Town.
